
- As boilers are generally deeper than the 300mm depth of our tall wall cabinets you must bring the wall cabinet forward and attach the cabinet to the end panels (min. depth 400mm).
- The end panels need to be securely attached to the wall with L-brackets.

What you need:

- 1. Tall Wall Unit 900 x 600mm (Leaving back panel out) Includes: 900mm height tall wall cabinet, 895 x 596mm door & 110 degree hinges.
- 2. Base End Panels 900 x 650mm (Cut to 900 x 400mm size) Optionally use Tall End Panels 2400 x 650mm cut to size if end panels need to run down to the worktop.
- 3. L-brackets

Please note: Boilers vary in size and there is no set standard. This will have an effect on filler/ door/end panel sizes, please check boiler dimensions carefully prior to installation to ensure the housing is suitable for the boiler it's being used for.

- (a) where the Goods are to be collected from the Delivery Address, the 3rd Business Day from the date of the Supplier's notification that the Goods are ready for collection (whether or not the Customer actually collects the Goods by such date); or
- (b) where the Goods are to be delivered to the Alternate Delivery Location, at the time of the Goods' arrival at the Alternative Delivery

Location; (the Delivery Date).

- 6.6 Notwithstanding clause 6.3, if the Supplier fails to deliver the Goods its liability shall be limited to the costs and expenses incurred by the Customer in obtaining replacement goods of similar description and quality in the cheapest market available, less the price of the Goods. The Supplier shall have no liability for any failure to deliver the Goods to the extent that such failure is caused by a Force Majeure Event or the Customer's failure to provide the Supplier with adequate delivery instructions or any other instructions that are relevant to the supply of the Goods.
- 6.7 If the Customer fails to accept delivery of the Goods in accordance with Clause 6.5, then except where such failure or delay is caused by a Force Majeure Event or the Supplier's failure to comply with its obligations under the Contract in respect of the Goods, the Supplier shall store the Goods until delivery takes place, and charge the Customer for all related costs and expenses (including insurance). Such charge to be equal to 15% of the value of the order.
- 6.8 If 14 Business Days after the day on which the Supplier notified the Customer that the Goods were ready for delivery, the Customer has not accepted or taken delivery of them, the Supplier may resell or otherwise dispose of part or all of the Goods and recover its reasonable storage and selling costs in respect of the Goods and:
- (a) Where the Customer has paid for the Goods in full, account to the Customer for any excess sums recovered over the price of the Goods and such storage and selling costs; or
- (b) Where there are insufficient funds to cover the storage or selling costs or where the Customer has not yet paid for the Goods in full, charge the Customer for any shortfall below the price of the Goods to cover such costs.
- 6.9 The Customer shall not be entitled to reject the Goods if the Supplier delivers up to and including 10% less than the quantity of Goods ordered, but a pro rata adjustment shall be made to the (Order invoice) on receipt of notice from the Customer that the wrong quantity of Goods was delivered.
- 6.10 The Supplier may deliver the Goods by installments, which shall be invoiced and paid for separately. References in these Conditions to delivery of the Goods shall, where applicable, be read as to include reference to delivery of the Goods by installments. Each installment shall constitute a separate Contract and any delay in delivery or defect in an installment shall not entitle the Customer to cancel any other installment.

7. QUALITY

Warranty

- 7.1 The Supplier warrants that on delivery, and for a period of 10 years (or other period as expressly confirmed by the Supplier in writing in the Acceptance Notice) from the date of delivery (Warranty Period), the Goods shall:

 (b) the defect arises because the Customer
 - (b) the defect arises because the Customer failed to follow the Supplier's oral or written instructions as to the storage, commissioning, installation, use and maintenance of the Goods (including all instructions in the technical guide and the door care guide as published by the Supplier) or (if there are none) good trade practice regarding the same;
 (c) the defect arises as a result of the
 - (c) the defect arises as a result of the Supplier following any drawing, design or Specification supplied by the Customer;
 - (d) the Customer works, alters, tailors or repairs such Goods (including drilling the Goods) without the written consent of the Supplier;

(CONTINUED OVERLEAF)

- (e) the defect arises as a result of fair wear and tear, willful damage, negligence, or abnormal storage or working conditions; or
- (f) the Goods differ from their description as a result of changes made to ensure they comply with applicable statutory or regulatory requirements.
- 7.3 Except as provided in this clause 7, the Supplier shall have no other liability to the Customer respect of the quality of the Goods.

Faulty Goods

7.4 If the Customer gives notice in writing to the Supplier that some or all of the Goods do not comply with the warranty set out in clause 7.1 (Faulty Goods), the Supplier shall, at its option repair or replace the Faulty Goods, or refund the price of the Faulty Goods in full. The Supplier will not be responsible for any associated costs in relation to the replacement of Faulty Goods. - 7.8 If the Customer gives notice in writing to the Supplier within 14 Business Days of the Delivery Date that some or all of the Goods delivered were supplied incorrectly (Incorrectly Supplied Goods), the Supplier will, subject to verification that the Goods have been supplied incorrectly, replace the Incorrectly Supplied Goods with the correct Goods and will arrange for the

Incorrectly Supplied Goods to be collected from the Customer within a reasonable time period. correctly Ordered Goods

- 7.9 If the Customer gives notice to the Supplier that some or all of the Goods supplied were ordered incorrectly or are no longer needed (Incorrectl Ordered Goods), then the Supplier may (at its discretion) accept the return of the Incorrectly Ordered Goods, and where the Incorrectly Ordered Goods have been paid for, issue a credit note to the Customer for the Incorrectly Ordered Goods, subject to the following conditions:

8. TITLE AND RISK

- 9.5 The Supplier may invoice the Customer for the Goods on or at any time after the Commencement Date.
- 9.6 The Customer shall pay the invoice in full and in cleared funds by the due date as stated on the invoice, or within 30 Business Days of the date of the invoice, whichever is the earliest. Paymen shall be made to the bank account nomi writing by the Supplier, or by cash or credit card. Time of payment is of the essence. 9.7 If the Customer fails to make any payment due to
- the Supplier under the Contract by the due date for payment, then the Customer shall pay interest on the overdue amount in accordance with the Late Payment of Commercial Debts (Interest) Act

CLEANING

We recommend the following door cleaning instructions for all of our doors:

Clean the doors using only a solution of 95% luke warm water with no more than 5% soap Do not spray anything onto your doors - this includes the solution recommended above Use a clean damp (not wet) cloth Dry with a soft clean cloth. If it is a timber door run the cloth along the grain direction Any cooking marks must be wiped immediately Do not allow liquids to seep into joints of doors, wipe any spillages immediately

Do not use any of the products listed below to clean the door as it may mark and damage the surface:

Wax furniture polish Bleach / chlorine based cleaning products Abrasive cleaners Solvents Multi-purpose cleaners Alcohol based cleaners Ammonia or any other similar product Scouring pads or abrasive cloths

ENVIRONMENTAL INFORMATION

Please be aware that localised or intense heat/steam can damage fascias, subsequently the use of small appliances such as kettles, toasters etc. in close proximity to your kitchen fascias should be avoided. Doors should not be exposed to extreme temperature changes. Due to their manufacturing process vinvl doors must not be exposed to temperatures above 70º C as this may cause damage to the door's surface.

INSTALLER CARE INSTRUCTIONS

INSTALLER CARE INSTRUCTIONS

Before commencing any work on doors or accessories, i.e. hinge boring, handle installation, cutting etc. please inspect the product thoroughly, making sure it meets your requirements for colour consistency and that it is free from scratches or blemishes. Once the product has been altered in any way from the state it was supplied it cannot be replaced.

CARE WHEN FITTING

Always handle doors / drawers with care to avoid damage When fitting hinges and handles to doors / drawers please ensure doors are placed on a clean and smooth cushioned surface to avoid scratches to the product.

FOIL / VINYL / OVER LACQUERED DOORS

Some doors may have a protective film on the face. Direct exposure to sunlight may cause an adverse effect therefore it is recommended you remove this film as soon as possible after fitting. Due to their manufacturing process vinvl doors must not be exposed to temperatures above 70° C as this may cause damage to the door's surface.

TIMBER / VENEER / PAINT TO ORDER DOORS

Timber is a natural product; therefore colour, grain structure and features will differ from door to door. Raw timber doors must be treated before use.

Timber and veneer doors have a unique and natural characteristic and because of this colours may change over time when exposed to sunlight. Please be aware of this natural colour change when ordering additional doors to suit a previous install. We also recommend you change your timber door samples every six months due to this reason.

Timber can be prone to expansion and shrinkage based upon the environment which it is installed in. Timber and veneered doors are affected by moisture; if there is too much moisture in the environment it can have an adverse effect on the door over a period of time and it may lead to timber expanding, especially during winter periods. Excess moisture may also be found in new builds and properties where renovation work has been carried out; examples include plastering or floor screeding, etc. In the summer months when the environment is drier, shrinkage may occur in the timber.

This natural movement of timber may cause the surface finish of the timber / veneered door (i.e. painted, varnished, lacquered finishes, etc) to move with the timber. If this occurs then there is a chance that it may result in shrinkage and hairline cracks appearing on the door.

Please check the moisture content of a room before installing timber or veneer doors. The above also applies to Paint to Order doors.

ENVIRONMENTAL INFORMATION

Newly plastered rooms, plaster repairs, floor screeding, renovations, etc should be left to dry out thoroughly before installation of doors, whatever their material. When fitting doors adjacent to an oven, a suitable heat shield must be used.

DOOR COLOUR AND UV LIGHT

Any door range, whether it be over lacquered, vinyl wrapped or painted will change colour over time due to natural UV exposure. Please be aware of this natural occurrence if replacing doors previously installed.

DOOR STORAGE

Doors should be stored on a stable flat stillage in a horizontal position. Please ensure doors are placed in a cool and dry area.
